

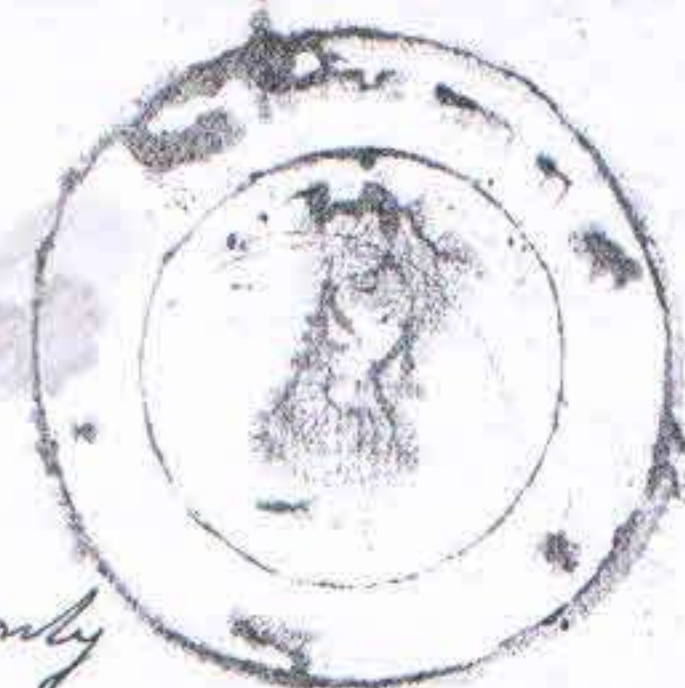

TRUST DEED OF
"MAYA MEMORIAL EDUCATION TRUST"

THIS DEED OF TRUST made this the 6th day of January 1995
Between Smt. Daiwati Devi, wife of Shri Pitaram Purbey (Present
address 31, Meherkunj Apartment - New Pathi putra Colony, Patna - 13)
Resident of P.O. Rosera, Dist: Samastipur here in after called
the "SETTLOR" (which expression shall unless excluded by or
repugnant to or context thereof, be deemed to include his executors,
administrators and representatives) of one Part. AND

herein after jointly referred to as 'TRUSTEES' (which expression shall
unless excluded by or repugnant - to or consistent with the subject

or context thereof, be deemed to (P/2) include the Trustees or Trustees for the time being of these presents and their successors in office) of the other part.

WHEREAS:

- (a) The SETTLOR is desirous of establishing a charitable trust for educational purposes and
- (b) The TRUSTEES have, at the request of the SETTLOR, agreed to act as the first trustees of these presents, as testified by their being parties to and executing these presents.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. The SETTLOR has handed over a sum of Rs. 2,100/- (Rupees two thousand one hundred only) to hold and stand possessed for the same (herein after for brevity's sake referred to as "TRUST FUND" which expression shall also include cash and any other property and investment of any kind whatsoever unto which the same or any part thereof might be converted, involved or varied from time to time or such as may be acquired by the trustees or come to their hands by virtue of these presents or by operation of law or by donations, gifts, charity or otherwise howsoever in relation to these presents) upon the Trust and with and subject to the powers, provisions, agreements and declarations herein after declared and contained of and concerning the same. (P/3)

2. The name of the trust shall be "MAYA MEMORIAL EDUCATION TRUST."

3. The objects for which this trust is established is education and for this purpose.

3/1. To establish, support, acquire, run and/or grant-aid and other financial assistance to schools, colleges, hostels, boarding houses, laboratories and other institutions of like nature for use of the students and the staff and also generally for the development and/or advancement of education and diffusion of knowledge amongst the public in general.

3/2. To establish, construct, maintain and run educational institutions for education purposes and not for purposes of profit.

4. TRUSTEES.

4/1. The first trustees shall remain the trustees of the Trust for their life time except in the following circumstances:-

- (a) if he dies, or
- (b) if he disclaims, or
- (c) if he desires to be discharged, or
- (d) if he refuses to act, or
- (e) if he is found to be of unsound mind by a court of competent jurisdiction, or
- (f) if he is convicted by a court of any offences involving moral turpitude and sentenced in respect thereof to imprisonment, or
- (g) if he becomes unfit or incapable to act as trustee.

4/2. The trustees shall be chargeable only for such moneys, stocks, shares and funds as shall

actually come into their hands and a trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other trustees, nor of any banker or other person with whom the trust property or any securities may have been deposited or kept.

4/3. The trustees may reimburse themselves of all expenses actually incurred by them in connection with the trust or their duties relating thereto. They may be entitled to receive remuneration for any service rendered by them.

4/4. The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matter in respect thereof in course of management of trust properties, or in relation to the carrying out of the objects and purposes of the trust as well as of all assets, credits and effects of the trust properties. (P/5)

4/5. The trust will be managed by a "Board of Trustees". The first trustee will be the first members of the Board of Trustees. The number of members of the Board of Trustees shall not be less than two nor more than eleven.

4/6. The members of the Board of Trustees may appoint one of them as managing trustee who will be the Chairman of the meeting of the Board of Trustees.

4/7. The first Managing Trustee will be Shri R. Sebastian who will hold the office of the Managing Trustee till he resign or the Board of Trustees by majority decision appoint some other person in his place as Managing Trustee.

5. POWERS OF THE BOARD OF TRUSTEES.

- 5/1. To form Societies under Societies Regulation Act, 1860 for educational purposes and may also get this trust registered under the Societies Registration Act, 1860.
- 5/2. To accept any donation, contribution, grant or subscription in cash or in kind from any person, body or body of persons or trust, with or without conditions in the name of the trust or in the name of any educational institution run or conducted by the trust.
- 5/3. To apply the whole or part of the income of the trust fund or accumulation thereof or whole or part of the trust fund to any one or more of the objects of the trust as the board of trustees may in their discretion from time to time determine. (P/6)
- 5/4. To convert and deal with the trust property and/or to carry the investments for the time being.
- 5/5. To purchase, construct or hire or take on lease any immovable or movable property for all or any of the purposes of the said trust at such price, cost or rent and on such terms and conditions and for such period and with or without option for renewal as the board of trustees may think fit.
- 5/6. To appoint other trustees for such period or on such terms as to retirement and reappointment as the board of trustees for the time being consider proper.

- 5/7. To appoint additional members of the Board of trustees within the limits prescribed in Para. 4/5 out of the trustees appointed under Para 5/6 for such period or on such terms as to retirement and reappointment as the board of trustees for the time being consider proper.
- 5/8. To form and amend rules/by-laws for the conduct and regulation of the meeting of the board of trustees.
- 5/9. To appoint Managing Committee / Committees for running the educational institutions run or conducted by this trust and to make vary, alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the trust and otherwise for giving effect to the object of the trust.
- 5/10. To sell, dispose off, alienate or otherwise deal with any property comprising the trust fund. (P/7)
- 5/11. To let out, lease, devise, mortgage, charge or licence any property belonging to the trust for such rent or compensation and on such terms and conditions and for such period as the board of trustees may think fit.

5/12. To borrow or to raise or secure payments of moneys and also to lend money either with or without security.

5/13. To open account in the name of the trust, trustees and/or institutions run/conducted by the trust with a bank or banks, to operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the members of the board of trustees or by an agent appointed by the board of trustees.

5/14. To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the trust fund.

5/15. To delegate by power of attorney or otherwise by way of resolution, to any trustee or trustees or any other person or persons powers and authorities employed by law or conferred by statute or vested in the trustees by these presents. The trustees shall, however, not be held liable or responsible for the acts or defaults of any such person or persons but only for their own respective acts and defaults.

5/16. To set a part and/or allocate the whole or part of the income of the corpus of the trust fund or part thereof for any of the objects of the trust. (P/8)

- 5/17. To join, co-operate or amalgamate this trust with other or others having similar or allied objects, upon such terms and conditions as the Board of Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this trust.
- 5/18. The Board of trustees will exercise control over the use of the funds of this trust as well as the educational institutions run by this trust.
- 5/19. The property, movable and immovable belonging to this trust will vest in the Board of trustees.
- 5/20. To do such other things as are incidental or conducive to the attainment of the objects of the trust.

6. IT SHALL BE LAWFUL FOR THE BOARD OF TRUSTEES.

- 6/1. To give aid by way of donations out of the income of the corpus of the trust fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India which may have been established or which may hereafter be established for like charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organisations or trustees to start, maintain, or carry out such charitable objects as are mentioned in these presents or any of them.

6/2. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things proper for such purpose without being responsible for any loss occasioned thereby. (P/9)

6/3. To apply to the Government, Public bodies, urban local, municipal, district and other bodies, Corporation, Companies or persons for and to accept grant of money and of aid, donations, gift, subscriptions and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, Public and other bodies, Corporation, Companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

6/4. To take over or amalgamate with any other Charitable Trust, Society, association or institution with similar objects.

6/5. To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising or maintaining any branch of the trust or any other trust or its branches with objects similar to those of this trust and to promote or carry on the affiliation or amalgamation of such other trust with this trust.

- 6/6. To take over, acquire, manage, control or aid any existing institutions or institutions having objects either wholly or in part similar to the objects of this trust and on such terms and conditions as may be thought expedient.
- 6/7. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the Trustees, Societies, Institutions or Associations with which this Trust is authorised to amalgamate. (P/10)
- 6/8. To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the Trust, Societies, Institutions or Associations with which this trust is authorised to amalgamate.
- 6/9. It shall be lawful for the board of Trustees of these presents at any time if they so desire, to transfer and hand over the Trust in their possession or control to any other society, corporation, institutions, trust or organisation on such terms and conditions as the board of trustees shall in their absolute discretion think fit and proper to be held by the society, corporation, institutions, trust or organisation, upon the same trustees and with and subject to the powers, provisions, agreements

and declaration appearing and contained in these presents, subject to such modifications as may be necessary and consequent to the transfer of the Trust fund to such Society, Corporation, institutions trust or organisation, the trustees for the time being of these presents shall become discharged from the Trust here of relating to such Trust funds or properties which may be transferred or conveyed as aforesaid.

7. The accounting year of the trust shall be from April to March.

8. The office of the trust shall be situated at 31, Meher Kunj Apartment, New Pathiputra Colony, Patna-800013 unless changed by the Board of Trustees. (P/11)

9. In case of failure of this trust for any reason, the trust fund will be applied for similar objects only.
